## **CITY OF McLEANSBORO - ALTERNATIVE TRANSPORTATION PERMIT**

1. No alternative vehicle shall be operated without obtaining a proper permit from the City of McLeansboro. Permits shall be granted beginning January 1st of the current year through December 31st. The cost of this permit is \$50 annually (pro-rated to \$25 after July 1<sup>st</sup>). Insurance coverage is to be verified prior to obtaining/renewing permit.
2. Every application for a permit shall be made on a form supplied by the City of McLeansboro and shall contain the following information:
  1. Name and address of applicant
  2. Name of liability insurance carrier
  3. Description of vehicle, including make, model and year
  4. Signed waiver of liability by applicant releasing the City of McLeansboro from any and all future claims resulting from the operation of their vehicle on City streets
  5. Photo copy of applicable liability coverage card for vehicle and driver's license.

Alternative Vehicles Addressed: Golf carts: Both electric and gas powered; and utility-terrain utility vehicles with the following equipment:

1. Horn
2. Brakes and brake lights
3. Turn signals on front and rear
4. Steering wheel
5. Rubber tires
6. Rearview mirror
7. Headlights that emit 500 feet to front
8. Taillights that emit at least 100 feet from rear
9. Approved "Slow Moving Vehicle" emblem on rear of vehicle
10. Seat belts

### ***RULES AND REGULATIONS***

1. No person shall operate a qualified golf cart or utility terrain vehicle without obtaining a permit from the McLeansboro Police Department.
2. Operator must have valid driver's license.
3. Vehicle must be inspected to insure that the vehicle is safe.
4. The applicant must provide evidence of insurance in compliance with the provisions of Illinois statutes as minimum liability insurance for passenger vehicles to be operated on the roads of the State of Illinois.
5. The City of McLeansboro may suspend or revoke a permit granted hereunder upon finding that the holder thereof has violated any of the provisions of City ordinances or if there is evidence that the permitted cannot safely operate the motorized vehicle.
6. Persons violating any provisions of City ordinances shall be guilty of a petty offense and shall be punished according to City Ordinance.
7. Every person operating an alternate vehicle pursuant to permit hereunder on designed City streets has all the rights and duties applicable to a driver of any other vehicle pursuant to the State highway traffic laws and regulations except when those provisions cannot reasonably be applied to motorized vehicles.
8. Vehicles will not exceed posted speed limits.
9. Vehicles cannot be operated on City sidewalks or in City parks other than parking areas.
10. Golf carts and utility terrain vehicles must be operated only on City streets, except where prohibited. Golf carts and utility terrain vehicles may not be operated on streets, highways and roads under the jurisdiction of the Illinois Department of Transportation (Highway 242, Highway 142, and Highway 14), or the intersection of Highway 14 (Randolph Street) and South Pearl Street, or the Hamilton County Highway Department.



**UNCONDITIONAL AND FULL GENERAL RELEASE  
OF LIABILITY, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE**

THIS IS A LEGALLY-BINDING UNCONDITIONAL AND FULL GENERAL RELEASE OF LIABILITY, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE MADE BY ME,

(HEREINAFTER REFERRED TO AS OPERATOR) TO CITY OF MCLEANSBORO (HEREINAFTER REFERRED TO AS CITY).

I FULLY RECOGNIZE THAT THERE ARE DANGERS AND RISKS TO WHICH I MAY BE EXPOSED BY OPERATING A GOLF CART OR UTILITY-TERRAIN VEHICLE ON CITY STREETS. THE FOLLOWING ARE DESCRIPTIONS AND/OR EXAMPLES OF SIGNIFICANT DANGERS AND RISKS ASSOCIATED WITH THIS ACTIVITY: INJURY TO MYSELF OR OTHERS, DAMAGE TO MY PROPERTY OR THAT OF OTHERS, DEATH OF MYSELF OR OTHERS.

IN NO EVENT SHALL THE CITY BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN TORT, CONTRACT OR ANY OTHER LEGAL THEORY, IN CONNECTION WITH OR ARISING OUT OF OPERATOR'S USE OF A GOLF CART OR UTILITY-TERRAIN VEHICLE ON CITY STREETS.

THE OPERATOR, AS OF THE DATE BELOW, SHALL HEREINAFTER SAVE, HOLD HARMLESS AND INDEMNIFY THE CITY AGAINST ANY AND ALL LIABILITY, CLAIMS, CAUSES OF ACTION, AND COSTS OF WHATSOEVER KIND AND NATURE INCLUDING, WITHOUT BEING LIMITED TO INJURY, DAMAGE, LOSS INCLUDING DEATH, RESULTING FROM, ARISING OUT OF, OR OCCURRING IN CONNECTION WITH MY USE OF THIS GOLF CART OR UTILITY-TERRAIN VEHICLE ON CITY STREETS.

I UNDERSTAND THAT THE CITY OF MCLEANSBORO HAS AN ORDINANCE GOVERNING THE USE OF QUALIFIED GOLF CARTS AND UTILITY-TERRAIN VEHICLES ON CITY STREETS AND HEREBY AGREE TO CONFORM TO ALL REQUIREMENTS OF THE CITY ORDINANCES AT ALL TIMES. I HAVE HAD THE OPPORTUNITY TO READ SAID ORDINANCE AND THE "RULES CONCERNING ALTERNATE TRANSPORTATION FOR THE CITY OF MCLEANSBORO" AND MY SIGNATURE BELOW ACKNOWLEDGES THAT I WILL COMPLY WITH THIS ORDINANCE AND SAID RULES AS WELL AS ALL OF THE APPLICABLE TRAFFIC LAWS OF THE STATE OF ILLINOIS AT ALL TIMES WHEN OPERATING THIS VEHICLE ON CITY STREETS.

I, THEREFORE, AGREE TO ASSUME AND TAKE UPON MYSELF ALL OF THE RISKS AND RESPONSIBILITIES IN ANY WAY ASSOCIATED WITH THIS ACTIVITY. IN CONSIDERATION OF AND RETURN FOR THE OPPORTUNITY TO OPERATE A GOLF CART OR UTILITY-TERRAIN VEHICLE ON CITY STREETS, I RELEASE THE CITY (AND CITY COUNCIL, EMPLOYEES, AND AGENTS) FROM ANY AND ALL LIABILITY, CLAIMS AND ACTIONS THAT MAY ARISE FROM INJURY OR HARM TO ME OR OTHERS, INCLUDING DEATH, OR FROM DAMAGE TO MY PROPERTY OR PROPERTY OF ANY OTHER IN CONNECTION WITH THIS ACTIVITY. I UNDERSTAND THAT THIS RELEASE ALSO COVERS LIABILITY, CLAIMS AND ACTIONS CAUSED ENTIRELY OR IN

PARTY BY ANY ACTS OR FAILURES TO ACT, INCLUDING BUT NOT LIMITED TO NEGLIGENCE, MISTAKE, OR FAILURE TO ENFORCE, SUPERVISE, OR MAINTAIN.

I ASSURE THE CITY THAT THERE ARE NO HEALTH-RELATED REASONS OR PROBLEMS WHICH PRECLUDE OR RESTRICT MY PARTICIPATION IN THIS ACTIVITY. I FURTHER ASSURE THE CITY THAT I HAVE ADEQUATE HEALTH AND LIABILITY INSURANCE NECESSARY TO PROVIDE FOR AND PAY ANY MEDICAL COSTS OR PROPERTY DAMAGE THAT MAY DIRECTLY OR INDIRECTLY RESULT FROM MY PARTICIPATION IN THIS ACTIVITY, AND I WILL INDEMNIFY AND HOLD THE CITY HARMLESS FOR ANY SUCH MEDICAL COSTS OR PROPERTY DAMAGE.

I UNDERSTAND THAT THIS RELEASE MEANS I AM GIVING UP, AMONG OTHER THINGS, RIGHTS TO SUE THE CITY, ITS CITY COUNCIL, EMPLOYEES, AND/OR AGENTS FOR INJURIES (INCLUDING DEATH), DAMAGES, OR LOSSES I MAY INCUR OR CAUSE. I ALSO UNDERSTAND THAT THIS RELEASE BINDS MY HEIRS, EXECUTORS, ADMINISTRATORS, AND ASSIGNS, AS WELL AS MYSELF.

I HAVE READ THIS ENTIRE RELEASE, I FULLY UNDERSTAND IT, AND I AGREE TO BE LEGALLY BOUND BY IT.
