Mrs. Pat Stevens let the council know that the Zoning Board of Appeals (ZBA) met on January 4, 2022, to discuss placing a new mobile home on the lot at 604 East Broadway, which is in a zone that does not allow trailers. Mr. Glenn made a MOTION TO ENTER INTO A CONTRACT WITH DAVID HARMON AS THE CITY OF MCLEANSBORO'S CONTRACTED WATER OPERATOR IN THE AMOUNT OF \$600.00 PER MONTH, second Mr. Cox. Roll Call: Glenn, Cox, Maulding, Murk, Bowman, Johnson. Ayes – 6, Nay – 0. Motion passed.

Mr. Cox made a MOTION TO ENTER INTO A CONTRACT WITH LOWELL HUFFSTUTLER AS THE CITY'S TEMPORARY DEPUTY TREASURER WITH THE AMOUNT TO BE PAID TO BE DETERMINED AT A LATER TIME BY MAYOR MAY.
