Following the Pledge of Allegiance, Mayor Chad May called the regular meeting of the McLeansboro City Council to order. Roll call: Don Cox, Tom Maulding, Billy Glenn, Tom Murk, Sharon Bowman, Jeff Johnson - present.

Mr. Cox made a MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING OF JANUARY 10, 2022, second Mr. Johnson. Roll call: Cox, Johnson, Maulding, Glenn, Murk, Bowman. Ayes – 6. Nay – 0. Motion passed.

Justin Barrow presented the Public Works department report for January 2022, Chief Nathan Taylor presented the Police Department report for January 2022 and Fire Chief Jim Morris presented the Fire Department report for January 2022.

Mrs. Brooke Morrison from Bellwether discussed several reports regarding budget, expenditures, and revenue. Mr. Cox made a MOTION TO APPROVE THE DECEMBER FINANCIAL REPORTS, JANUARY COLLECTOR'S & TREASURER'S REPORTS AND JANUARY BILLS & TRANSFERS, second Mr. Johnson. Roll call: Cox, Johnson, Maulding, Glenn, Murk, Bowman. Ayes – 6. Nay – 0. Motion passed.

Ms. Angie Strickland, a representative from ROC One Stop in McLeansboro spoke during public comments. She asked the council to allow liquor sales on Sunday. There were no further public comments.

The February 2022 Zoning Report was presented to the council. Mr. Murk made a MOTION TO APPROVE THE FEBRUARY 2022 ZONING REPORT AS PRESENTED, second Mr. Maulding. Roll Call: Murk, Maulding, Cox, Glenn, Bowman, Johnson. Ayes – 6. Nay – 0. Motion passed.

Mr. Glenn made a MOTION TO ACCEPT THE LOW PROPOSAL OF \$7,500.00 FROM KYLE POORE TO TEAR DOWN THE HOUSE LOCATED AT 211 SOUTH LOCUST, second Mr. Johnson. Roll Call: Glenn, Johnson, Cox, Maulding, Murk, Bowman. Ayes – 6. Nay – 0. Motion passed.

Mayor May read the bids submitted to the city for the demolition and cleanup of the building located at 508 South Jackson. The bids were as follows: Kyle Poore - \$26,000, Earth Services - \$34,700 and Big Creek Excavation - \$43,900. Mr. Maulding made a MOTION TO APPROVE THE LEASE AGREEMENT BETWEEN THE UNIVERSITY OF ILLINOIS EXTENSION AND THE CITY OF MCLEANSBORO FOR THE "GIFT GARDEN", second Mr. Glenn. Roll Call: Maulding, Glenn, Cox, Murk, Bowman, Johnson. Ayes – 6. Nay – 0. Motion passed.
