A discussion was had on updating the road repair fees that can occur when new taps are installed. The current code states that the road repair fee is a flat \$150, it was suggested that the fee be increased to \$150 + material.

Mayor May gave the first reading of Ordinance #22-1085 regarding the selling of excess equipment and furniture owned by the City of McLeansboro.

Mayor May gave the first reading of Ordinance #22-1086 updating Chapter 7 "Business Code", Article VII "Transient Merchants, Itinerant Vendors and Solicitors."
