Following the Pledge of Allegiance, Mayor Chad May called the regular meeting of the McLeansboro City Council to order. Roll call: Tom Maulding, Tom Murk, Sharon Hall, Jeff Johnson, Mark Brown, Jeff Reyling – present.

Mr. Murk made a MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING AND PUBLIC HEARING OF MAY 21, 2024 second Mr. Johnson. Roll call: Murk, Johnson, Maulding, Hall, , Reyling. Ayes - 6. Nay - 0. Motion passed.

During public comments Mrs. Kathy Wuebbels spoke about a water leak stemming from a fire hydrant located near Mrs. Wuebbels' residence at 1011 Meadow Hills Drive. Mr. John Perryman from the McCoy Library Board presented the estimate from C-Hill Civil Contractors to repair the porch and gutter at the McCoy Library. Mr. Perryman also represented the Kiwanis Club regarding a donation to offset the cost of a new PA System that will be installed on the Courthouse. Mr. John Scattone spoke regarding an issue with a neighbor's property.

Mr. Johnson made a MOTION TO EXTEND THE MOWING CONTRACT THE CITY CURRENTLY HAS WITH TRIPLE G LAWN CARE LLC, WITH A PRICE OF \$1500/WEEK FOR YEARS 2025, 2026, AND 2027. EXTRA LOTS MAY BE ADDED AT THIS PRICE UP TO 3 ACRES OR 15 LOTS, second Mr. Brown. Roll Call: Johnson, Brown, Maulding, Murk, Hall, Reyling. Ayes -6. Nay - 0. Motion passed.

Mr. Murk made a MOTION TO APPROVE THE BID MADE FOR PORCH AND GUTTER REPAIR FOR THE MCCOY LIBRARY FROM C-HILL CIVIL CONTRACTORS IN THE AMOUNT OF \$75,450.00 TO BE PAID OUT OF THE TIF ACCOUNT, second Mr. Brown. Roll Call: Murk, Brown, Maulding, Hall, Johnson, Reyling. Ayes -6 . Nay - 0. Motion passed.


Mr. Murk made a MOTION TO HELP OFFSET THE COST OF A PUBLIC ADDRESS SYSTEM TO BE PURCHASED BY THE KIWANIS AND INSTALLED ON THE COURTHOUSE IN THE AMOUNT OF \$1000.00, second Mr. Johnson. Roll Call: Murk, Johnson, Maulding, Hall, Brown, Reyling. Ayes -6 . Nay - 0. Motion passed.

No action was taken on item #9, regarding 305 East Olive.

Mr. Johnson made a MOTION TO ALLOW THE GIRL SCOUTS TO HAVE AN OVERNIGHT CAMP WITH TENTS AT KIWANIS PARK JULY 26-27, second Mr. Maulding. Roll Call: Johnson, Maulding, Murk, Hall, Brown, Reyling. Ayes -6 . Nay - 0. Motion passed.

At approximately 6:35pm, having completed City business, Mr. Johnson made a MOTION TO ADJOURN, second Mr. Murk. A voice vote was taken without dissent. Meeting Adjourned.
