Following the Pledge of Allegiance, Mayor Chad May called the regular meeting of the McLeansboro City Council to order. Roll call: Tom Maulding, Sharon Hall, Jeff Johnson, Mark Brown, Jeff Reyling, Duke Griesemer – present.

Mr. Brown made a MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING OF MAY 20, 2025, AND THE SPECIAL MEETING OF JUNE 3, 2025, second Mr. Reyling. Roll call: Brown, Reyling, Maulding, Hall, Johnson, Griesemer. Ayes - 6. Nays - 0. Motion passed.

During public comments, Mayor May read a thank you from Anna Anderson to Mark Brown and the street department for the work they did on her drive caused by the garbage truck. Mayor May also extended an invitation to the elected officials to the Southeastern Illinois Planning Commission dinner meeting on July 16 at 6:00pm at the Big Red Barn. There were no other public comments.

Mr. Johnson made a MOTION TO APPROVE THE CONSENT AGENDA WHICH INCLUDED MONTHLY FINANCIAL REPORTS INCLUDING BILLS AND TRANSFERS, JUNE ZONING REPORT, MAY DEPARTMENT REPORTS, ANNOUNCING THAT CITY FIREWORKS WOULD TAKE PLACE ON JULY 4 AT DUSK WITH A RAIN DATE OF JULY 5, 2025, ANOUNCING THAT THE CITY POOL WOULD BE CLOSED ON JULY 4, 2025, RESOLUTION 25-02 REGARDING MAINTENANCE UNDER THE ILLINOIS HIGHWAY CODE (MFT), AND FY26 BUDGET AMENDMENT #1 second Mrs. Hall. Roll Call: Johnson, Hall, Maulding, Brown, Reyling, Griesemer. Ayes - 6. Nays - 0. Motion passed.

A discussion was had regarding reclassing the zoning code for the area known as Hyatt's Addition.

Mayor May read, for the second time, Ordinance #25-1126, implementing a municipal grocery retailers' occupation tax and a municipal grocery service occupation tax.

Mr. Brown made a MOTION TO APPROVE THE CONTRACT FOR THE CITY ADMINISTRATOR. THIS CONTRACT IS VALID FROM MAY 1, 2025-APRIL 30, 2029 AND THE PAY WILL BEGIN ON JUNE 23, 2025, second Mrs. Hall. Roll Call: Brown, Hall, Maulding, Johnson, Reyling, Griesemer. Ayes - 6. Nays - 0. Motion passed.
