Mr. Murk made a MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING OF FEBRUARY 18, 2025, second Mr. Brown. Roll call: Murk, Brown, Maulding, Hall, Johnson, Reyling. Ayes - 6. Nays - 0. Motion passed.

During old business, Mayor May gave an update on Retail Strategies.

During public comments, Mr. John Perryman of the Kiwanis Club gave a presentation regarding the playground equipment the Kiwanis would like to put at the Kiwanis Park. Mr. Perryman was asking for a cash donation for the equipment. Rebecca Rush, a city resident spoke regarding the hobby animal ordinance, specifically how many chickens are allowed within city limits. Ms. Janet Braden, Ms. Brenda Simmons and Mr. Denny Crain representing the Hamilton County Recreation Center spoke regarding their vision for building a recreation center in the McLeansboro area. Mayor May read, for the first time, Ordinance #25-1123 regarding revising Article 5 – Supplementary Zoning Regulation of the McLeansboro City Code.
