Following the Pledge of Allegiance, Mayor Chad May called the regular meeting of the McLeansboro City Council to order. Roll call: Tom Maulding, Sharon Hall, Jeff Johnson, Mark Brown, Jeff Reyling, Duke Griesemer – present.

Mrs. Hall made a MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING OF SEPTEMBER 16, 2025, second Mr. Maulding. Roll call: Hall, Maulding, Johnson, Brown, Reyling, Griesemer. Ayes - 6. Nays - 0. Motion passed.

During public comments there was one senior civics' student that introduced herself. There were no further public comments.

Mr. Kevin Kern and Mr. Brent Williams from Snedeckers Risk Management discussed the liability, workman's compensation, unemployment insurance policy renewal from Illinois Counties Risk Management Trust (ICRMT) and health insurance renewal with Hope Trust.
